We believe that investing in smaller companies can produce excellent returns for investors. However the smaller companies sector is different to the Australian large cap market:

- It has a diverse range of industries, and the index is not dominated by a handful of stocks;
- It is inherently a growth sector;
- The market is inefficient, as there is limited independent research available;
- There is a wide dispersion in individual stock performance.

This gives the **opportunity for skilled investors to add significant value over the Index.** You can see this opportunity in the long term outperformance of smaller companies managers* - the median return is over 7%pa better than the Index.

However, to take advantage of this opportunity, **consistent, detailed research** is necessary. Uncovering great potential investments takes skill, hard work and experience. The research effort also needs to identify the multiple aspects of risk, to understand how they could affect the company's ability to deliver.
